### Parental Release and Waiver Liability

The following form must be completed by all parents or legal guardian of minor children less than 18 years of age.

As a parent or legal guardian, I am freely assuming all the risks, (including physical and legal risks), dangers, hazards on behalf of the camper associated with participation in the Sharkx Summer Day Camp and its activities.

As a parent or legal guardian, I acknowledge and agree that in exchange for and as a condition to the camper's participation in the activity, I accept all liability for any loss or damaged to property caused by or contributed to by the camper.

I, parent or legal guardian, further acknowledge the following:

- I am aware that the camper's participation in the activity may be hazardous and could result in damage or injury;
- The camper has appropriate health and medical insurance in case of an injury.
- The camper is in satisfactory physical and mental condition to safely participate in the activity with no known risk of putting the camper, or any other camper or Sharkx summer day camp staff by virtue of the camper's participation in the activity.
- I certify that, to the best of my knowledge, the medical information requested above is complete and correct, and that no health-related situations preclude camper's participation in camp activities.
- Agree to assume all risk arising from camper's participation in camp activities, including but not limited to, any activities that may present risk of bodily injury.
- Agree to save, hold harmless, discharge and release Sharkx Summer Camp, its staff and volunteers for any and all liability, claims, causes of action, damages or demands in any connection with camper participation in any program or attendance to camp activities including transportation to, at, or from camp activities.
- Any medical expenses for Camper's health and well-being will be the responsibility of the parent/guardian.
- In the event that the camper is injured, ill or in need of medical attention and you are unable to be contacted, you authorize Sharkx Summer Day Camp staff to seek medical attention on your behalf.
- All kids must respect the staffs, the facility and camp rules. No violence, fighting, kicking, punching, swearing, or any negative energy. Not accepted
- The Camp Director is in the rights to terminate camper's attendance due to misbehavior, with no refund for early dismissal or misbehavior.
- Parents must only drop off and pick up their kids at the front of church Eglise Notre-Dame-de-Grace, 5333 Notre-Dame-de-Grâce, Montreal, Quebec H4A 1L2.
  - Parents won't be allowed to park their cars in the parking lot. (Drop off & pick kids up only). Can't stay.
- All campers must bring their assigned t-shirt Color for their age group everyday they are registered at camp. Must have it! This is for safety purpose to identify our kids and age group.

All forms must be filled out completely and payments in order to secure a place for your kids by June 19, 2020. If I cancel after the camp starts, Sharkx Summer Day Camp will reduce 100\$ off each week (non refundable).

For my kid(s) **registered for the extended care service**, If I come after 6pm I will be charged 20\$ each day for lateless.

I agree that the Sharkx Summer Day Camp may use photographs taken of the camper during the activity for promotional purposes. If I refuse, please mention it in writing.

Accordingly, I hereby release Sharkx Summer Day Camp and its agents, directors, officers and employees, staff and volunteers from any and all liability for any direct, special, incidental, consequential, punitive or exemplary damages, regardless of the nature of the claim arising from, or related to the Camper's participation in the activity.
