Parental Release and Waiver Liability

The following form must be completed by all parents or legal guardian of minor children less than 18 years of age.

As a parent or legal guardian, I am freely assuming all the risks, (including physical and legal risks), dangers, hazards on behalf of my child/children associated with the participation in the Sharkx Sports Programs and its activities.

As a parent or legal guardian, I acknowledge and agree that in exchange for and as a condition to the my child/children's participation in the activity, I accept all liability for any loss or damaged to property caused by or contributed to by my child/children.

I, parent or legal guardian, further acknowledge the following:

1. I am aware that my child's/children's participation in the activity may be hazardous and could result in damage or injury;
2. My child/children have appropriate health and medical insurance in case of an injury.
3. My child/children are in satisfactory physical and mental condition to safely participate in the activity with no known risk of putting my child, or any other participant or Sharkx Sports Programs staff by virtue of his/her participation in the program.
4. I certify that, to the best of my knowledge, the medical information requested above is complete and correct, and that no health-related situations preclude my child's/children's participation in Sharkx Sports Programs activities.
5. Agree to assume all risk arising from my child's/children's participation in Sharkx Sports Programs activities, including but not limited to, any activities that may present risk of bodily injury.
6. Agree to save, hold harmless, discharge and release Sharkx Sports Programs, its staff and volunteers for any and all liability, claims, causes of action, damages or demands in any connection with my child's/children's participation in any program or attendance to Sharkx Sports Programs activities including transportation.
7. Any medical expenses for my child's/children's health and well-being will be the responsibility of the parent/guardian.
8. In the event that my child/children are injured, ill or in need of medical attention and you are unable to be contacted, you authorize Sharkx Sports Programs staff to seek medical attention on your behalf.
9. All participants must respect the staff, the facility and rules.
10. No violence, fighting, bullying, swearing or any negative energy. Not accepted
11. The Sharkx Sports Programs director is in the rights to terminate participant's attendance due to misbehavior, with no refund for early dismissal or misbehavior.
12. All payments and forms have to be completed in order to secure a place for your child/children).
13. If I cancel before the program starts, the Sharkx Sports Programs will **deduct a 75\$ admin fee** from the registration payment from each child.
14. If I cancel after the program starts, Sharkx Sports Programs **will not refund me** (no reimbursements).

15. For my kid(s) **registered for the extended care service (Sports day camp only)**, If I come after 6pm I will be charged 5\$ per minute for lateless.
16. For my kid(s) **non-registered for the extended care service (Sports day camp only)**, If I come after 4pm I will be charged 5\$ per minute for lateless.
17. All participants must wear the SHARKX t-shirt of their assigned group everyday **(sports day camp only)**. It's a security measure to identify the participant.
18. I will only drop off and pick up my kid(s) at the front of the site **(Sports day camp only)** :
